UPCOMING VIRTUAL EVENTS - SAVE THE DATES

MCNAA is looking ahead to the 2022 Winter season and has planned two new virtual events for the beginning of the year:

1. Firekeeper's Daughter by Angeline Boulley, Sault Ste. Marie Tribe of Chippewa Indians On Monday, January 24, 2022 at 5:00 PM, MCNAA is hosting its fourth virtual book discussion on "Firekeeper's Daughter" by Angeline Boulley, Sault Ste. Marie Tribe of Chippewa Indians. The young adult novel is a coming of age story which explores identity and culture through the action of a mystery/thriller set in modern day northern Michigan. The book is a New York Times bestseller and has won the Goodreads Choice Award for Young Adult fiction. Barack and Michelle Obama's film development company has chosen the book to become a Netflix special, under agreement with the author to include indigenous people both in front of and behind the camera.

"Firekeepers Daughter" features a tough, athletic teenager, unsure of her future after high school. She is recovering from a hockey injury as well as the death of a beloved uncle, tying her to home. "...Daunis Fontaine's life is split between two communities that of her white French Canadian mother and the other of the Sugar Land Ojibwe Tribe of her late father. When Daunis witnesses a tragic murder, Daunis finds herself involved in an FBI investigation into drug trafficking in her community.



However, the investigation will uncover secrets and threaten many people, including many she knows. In this thrilling and dynamic story, Boulley tells a tale that is suspenseful, insightful and emotionally complex."

Readers will enjoy the well-developed characters and fast action of the book, as well as the thoughtful way the author incorporates native language - and references - into the main character's thoughts and decisions. As in previous discussions, readers are asked to select a quote from the book that has particular meaning for them, to share in a small group "break-out room" part of the program.

MCNAA DONATES COLLECTION OF NATIVE AMERICAN BOOKS TO THE PEABODY INSTITUTE LIBRARY OF DANVERS

On the 1st of December, MCNAA delivered nearly 100 Native American books to Peabody Institute Library of Danvers to enhance their Indigenous resources for the general public. These were duplicate books acquired throughout the years for MCNAA's library and not being used. In as much, MCNAA's office is located in Danvers, it was felt that we should donate the

excess books to the local library.

After a few visits to the Library to view their collection of Native American books, we found their inventory to be extremely limited. We, therefore, decided to ask to meet and with speak with library director Alex Lent to discuss the process to possibly make the books a part of the library's inventory. Mr. Lent was very much interested as he agreed that the library's inventory had very few books about the Native Peoples of this land. It was thereby decided they would like to increase the number of books but it would require the approval of the library's Board of Trustees. This was then presented at the Library's next monthly meeting and it was unanimously approved, giving Mr. Lent the go ahead to create a larger section of the library dedicated to Native American books.

The books were then slated for delivery within a month or two but, prior to beginning the process, it was

overwhelmingly delayed because of the Covid-19 outbreak and eventually put on the back burner for over a year.

Since that time, Mr. Lent had left his position and Noel Boc was hired as the new Director. After conversations over the past 4 months, the process was once again started thereby allowing the Library to take delivery and begin making these books part of their inventory. These books will also be housed on the 3rd floor in a special section for Native American readings.

This is exciting as we receive many requests for resources on Native American and we will be able to direct them to the local library where hours are more flexible than ours.

MCNAA – A SURPRISE RECIPIENT OF AN "END OF YEAR" YOUTH SUPPORT GRANT

Recently, we received a surprise notification that MCNAA was one of those chosen for an "End of Year" Youth Support Grant from the Native Youth Empowerment Foundation (NYEF). The mission of NYEF is to support Native youth statewide through providing small grants for education, workshops that promote professional development, cultural engagement initiatives, networking and various other resources that aim at intertribal inclusivity and youth empowerment."

The \$7,500 grant can be used to help support our Scholarship Program if this is what our board decides. According to the Foundation, individuals up to age 25 are considered youth and are eligible recipients to benefit from the funds. This is important because it includes many young people (18-24) who are seeking a profession and still in need of further support.

Currently, MCNAA's Scholarship Program provides needy Native students with funds for college-related expenses to help train future leaders in the community by assuring they are given the opportunity to compete for a college education or comparable degree/certification. An important goal of the program is to encourage students to use their newly-gained knowledge to give back to their communities.

This award is particularly exciting as these funds could be of help to MCNAA's Scholarship Program which has relied heavily on multiple fundraisers and a 2-year education grant to help endow the program. But with the pandemic limiting our fundraising events as well as the fact that the education grant has ceased, these unexpected funds from the NYEF will be an enormous help to funding college scholarships.

On behalf of the MCNAA Board, I would like to thank NYEF's Board for acknowledging our important work in the Native community, and look forward to the day when we can all get together again.

BIDEN'S INTERIOR DEPT. REVERSES TRUMP'S ATTEMPT TO STRIP MASHPEE WAMPANOAG LANDS OF RESERVATION STATUS

The Mashpee Wampanoag Tribe received an early Christmas gift from the U.S. Department of the Interior on Wednesday, December 22, 2021 when it received notification from Assistant Secretary of the Interior – Indian Affairs Bryan Newland that the tribe's reservation has been confirmed.

The decision reverses the action by the Trump administration's attempt in March 2020 to strip the tribe of its reservation, which includes 321 acres of land that was put into trust status during the Obama administration. The Obama decision was reversed by the Trump administration three years later in September 2018.

Mr. Newland confirmed that the Interior Department has authority under the Indian Reorganization Act to take such action, and further confirmed that the Tribe's Reservation has remained in

federally protected trust status since the Reservation land was first placed in trust six years ago on November 10, 2015.

"This is a momentous day for the Mashpee Wampanoag Tribe, for indigenous communities across the country, and for defenders of justice," said Mashpee Wampanoag Tribe Chairman Brian Weeden. "We are grateful that President Biden and his administration, including Secretary Deb Haaland, Assistant Secretary Bryan Newland, and Solicitor Bob Anderson, have faithfully implemented the law and respected the sovereign rights of our tribe to protect our reservation."

The 55-page decision had the support of the Massachusetts' two United States senators.

"I congratulate the Mashpee Wampanoag Tribe on this major victory, which conclusively reaffirms the trust status of their reservation," said U.S. Senator Elizabeth Warren (D-MA). "The Massachusetts congressional delegation and I have proudly stood with the Tribe throughout its fight to protect their ancestral homelands—a fight that should never have been necessary in the first place. I am glad to see the Biden Administration and the Department of the Interior finally issue this confirmation, and to end the attempt begun by the Trump Administration's to unjustly disestablish the Tribe's reservation."

"The Mashpee Wampanoag Tribe has withstood years of uncertainty after the Trump administration's unlawful, unprecedented and unjust attempt to abrogate their sovereignty and take away their Tribal lands," said U.S. Senator Ed Markey (D-MA). "The Department of the Interior's decision today finally lays to rest these wrongful actions and reaffirms the Mashpee Wampanoag Tribe's right to this land, which they have stewarded for more than 10,000 years. I join Tribal Leadership and the Wampanoag people in celebrating this decision and look forward to our continued partnership. We must take every opportunity to support and elevate Tribal sovereignty and land rights across the federal government as a cornerstone of our fight for a just, livable future."

Chairman Weeden said the decision allows the Mashpee Wampanoag Tribe to reclaim and protect their cherished land and better serve its people for generations to come.
